Therefore, on 14 May 2022, the Vendor and Purchaser entered into a 4th supplemental agreement to extend the date for the fulfillment or waiver of the conditions precedent of the Disposal under the Disposal Agreement from 15 May 2022 (as extended by the supplemental agreements entered into between the parties on 29 October 2021, 31 December 2021 and 31 March 2022) to 30 June 2022 (or such other date as the parties may agree in writing).

If the conditions precedent under the Disposal Agreement are not fulfilled or waived (if such condition precedent can be waived) on or before 30 June 2022 (or such other date as the parties may agree in writing), the obligations of the parties under the Disposal Agreement shall cease and none of the parties shall have any claim against the other parties, save for any antecedent breach thereof.

Saved as disclosed above, all the terms and conditions of the Disposal Agreement shall remain unchanged and in full force and effect and binding on the parties.
